This item has been added to ASFM Scott's Evaluation check list. For departments that have left items blank on their Funding Application we have contacted them and scheduled evaluations. As for those departments who have not submitted a funding application, they are contacted via 1) phone, 2) email and 3 )letter requesting they submit a Funding Application.

Commissioner Mongold inquired at what point do they lose their funding for not submitting a Funding Application. Marshal Tyree stated per §8-15-8.a submission of a Funding Application is not a requirement.

Chairman Gunnoe inquired as to the reasons a department may not be able to get their funding and Marshal Tyree responded that in order to get their funding, there has to be verification that departments have submitted their fire reports and recognition by the Commission as a department. So not submitting fire reports, and not being recognized by the Commission (or decertification) would be reasons for withholding funding. He noted to decertify a department the Commission would have to follow the guidelines set in §87CSR6.

### 1. Discussion/Consideration of WVPST Curriculum Update for Hazardous Materials.

Jamie Weller of WV Public Service Training presented the proposed curriculum updates to the Committee. He noted they are minor updates and that it will bring the curriculum up to the 2022 Standard.

Commissioner Keefer inquired if they were using the Jones and Bartlett publication and it was confirmed they are.

### 1a) Technician.

### **1b)** Awareness and Operations Levels.

Commissioner Keefer made a motion to recommend to the Full Commission to approve curriculum updates to Technician, Awareness and Operations from the 2017 Standards to the 2022 Standards, seconded by Commissioner Oldaker. With the ayes and nays having been taken on a voice vote.

### 2. Discussion/Consideration of Technician Level Rescue Classes

Commissioner White addressed the Committee explaining he received a question regarding whether Technician Level Rescue Classes are required to be tested.

Jamie Weller of WV Public Service Training (PST) provided a booklet (Cognitive and Psychomotor Testing for Technical Rescue Programs) to the Committee that explained the roles of testing, the types of testing, courses currently tested, comparisons to other states fire fighter training, comparison to other professions training, sampling of pass/fail percentages, summary of the information and PST's recommendation. PST's recommendation is to continue cognitive exams at the technician level and make no changes to the current program.

Chairman Gunnoe asked if there are any courses that don't require a written test. Mr. Weller responded that there are no written tests for the awareness and operations level except for hazmat, neither is there one for the Incident Safety Officer level. He entertained and answered questions on that topic.

Commissioner Mongold inquired if WVU Fire Services Extension (FSE) and PST are consistent in what they are doing. Mark Lambert of WVU FSE was not aware this was an agenda item, and he is requesting to be made aware if an item involving WVU FSE is on the agenda. Mr. Lambert stated that all classes tested as WVU will not give you credit without a test.

Chairman Gunnoe reviewed old curriculum and while it states tested it does not clarify whether it is written and that is the purpose of this discussion.

After further discussion Chairman Gunnoe requested Commissioner White add to the August agenda to bring information on the Awareness and Operations Level as to whether there is a written test.

Commissioner Oldaker made a motion to recommend to the Full Commission that for clarification a written test is a requirement of the Commission on Technical Level Classes, seconded by Commissioner Mongold. With the ayes and nays having been taken on a voice vote.

# **Other Business**

Mark Lambert of WVU FSE provided information on Junior Camp to be held 6/17/23 to 6/22/23. There are currently 85 to 90 signed up. If one of the Commission or Staff wishes to come by to please let him know. There is also to be a Women's National Fire Academy Weekend on 6/23/23-6/25/23. ## **Unfinished Business**

## 1. Consideration of update to 87CRS1.

Marshal Tyree presented the proposed updates to 87CSR1 to the Committee which would bring the State Fire Code to be better aligned with the National Fire Code. He noted two concerns that were brought up during the 5/31/23 Stakeholders meeting. One being the Fire Alarm requirements in the current State Fire Code (which is more stringent) compared to those in the current National Code. He encouraged those attending who were concerned with the proposed changes to submit Public Comments when filed. The other concern was under NICET (National Institute of Certification and Engineering Technologies). We currently require every company to have at least one person to have NICET 1 certification. A request was made that we make it a NICET 2 Level certification in 2.4.a. He also noted additional technical updates in the version before the Committee.

Marshal Tyree then entertained and answered questions regarding the timelines involved and processes necessary.

No action taken; item is on the main Fire Commission agenda.

# 2. Discussion on IBC and Adult Changing Stations.

Marshal Tyree addressed the Committee on his correspondence from Ms. Allison Bungard explaining the difficulties those with adult age disabled children face in traveling with them, due to lack of Adult Changing Stations. He intends to reach out to her again and his recommendation would be that a Building Code change as a whole would not be workable but perhaps, she could seek a Legislator to sponsor the particular language in IBC E142-21.

Commissioner George agreed with Marshal Tyree that a legislative fix would be the best solution and understands that Ms. Bungard has already spoken with House Judiciary Chairman Moore-Capito. He explained that until this was brought to his attention, he had not thought about the reality of taking care of adult age disabled children and the difficulties those who do face. He certainly thinks it is a worthy cause.
