Application for Public Display Fireworks Permit

Permit Information

- This application is intended to request a permit from the West Virginia State Fire Marshal's Office to have a lawful public fireworks display with fireworks strictly intended for such use and as permitted by law. Any violation of the West Virginia fireworks law (103CSR4) is a citable offense and will be pursued as such.
- Each public fireworks display shall be performed by a licensed West Virginia pyrotechnic operator and must be authorized prior to the display by the West Virginia State Fire Marshal's Office. It is the pyrotechnician's responsibility to ensure compliance with all applicable requirements set forth by NFPA 1123 for outdoor displays and / or NFPA 1126 for indoor displays.
- Applicant Restrictions No person, corporation, or other entity, having been convicted
 of a violation under 103CSR4 shall be eligible to obtain a permit for the display or sale of
 fireworks, or participate in any manner in the transportation, sale, or display of fireworks
 for a period of five (5) years from the date of conviction.
- It is the applicant's responsibility to obtain permission from the property owner as well as all required signatures from the local fire chief and to submit the permit application in a timely manner to allow time for review and processing.
- Submit the application to the West Virginia State Fire Marshal's Office, 1700 MacCorkle Ave SE, 4th Floor North, Charleston, WV 25314. The permit shall be valid only for the date / time / location listed on the application. Any variance thereof shall require a new permit form and fee to be submitted for authorization by the West Virginia State Fire Marshal's Office.
- Upon receipt of the completed fireworks display permit application including all required documents and fees, a representative of the West Virginia Fire Marshal's Office will review your application, and either approve or deny the application. If the permit is denied, the entire application and payment will be returned to the applicant. If the permit is approved, you will receive the permit via email prior to the display date.

<u>Application Definitions</u>

Name of Event This refers to the occasion or event that the fireworks will be

displayed at. i.e., 'Strawberry Festival', 'Italian Festival', etc.

Applicant / Sponsor This is the person, company or entity that orders, pays for, and holds

liability for the fireworks display.

<u>Point of Contact</u> This is the person that would be available during normal business

hours to answer any questions regarding the application or the

display.

Property Owner This is the legal owner of the property that the fireworks will be

displayed on. This can be a person, company, or government agency; but permission letter must be obtained and submitted with application.

<u>Insurance</u> Each fireworks display must be covered by liability insurance no less

than \$1,000,000.00. You must attach a copy of the insurance policy. List the Insurance company, the policy number, and the Policyholder, (the person, company or entity that carries the insurance covering the

fireworks display event).

<u>Location Description</u> This is the common name of the location where the fireworks display

will be held.: i.e., Football field, Fairgrounds, Riverfront, etc.

Rain Date A rain date is only valid if all the other variances remain the same: i.e.,

location, distances, delivery mode, etc. If anything, but the date changes, you must submit a new application form and fee.

Physical Address This is the location address: i.e., 140 main St, Rt. 250

South, etc.

<u>Fireworks Supplier</u> This is the company that supplies the display fireworks.

<u>Delivery Date</u> This is the date that you will receive the display fireworks from the

seller.

<u>Delivered To</u> This is the person who takes physical possession of the fireworks

upon delivery.

Storage Location Where the fireworks will be held at between delivery and actual

display?

Storage Type How will the fireworks be stored between delivery and display?

i.e., magazine TYPE 1, 2, 4 or 5 ONLY.

<u>Shells</u> Type and size – what is the largest size shell being shot and what

type of shells: i.e., aerials, multi shot cakes, etc., and how many shells

total.

<u>Responsible Person</u> The person accepting full financial responsibility to satisfy claims for

damages to property or personal injuries arising out of any omission.

(Section 9 on application).

Documentation and Information Required for the Permit

- ➤ PERMIT FEE The public display fireworks permit fee is set at \$50.00 for each shoot. Payment is payable to the West Virginia Fire Marshal's Office. THE FEE IS NON-REFUNDABLE.
- ➤ APPLICATION FEE Please be aware that there is a \$40.00 review charge. **THIS FEE IS** NON-REFUNDABLE
- MANUFACTURER / WHOLESALER / DISTRIBUTOR NAME and ATF and WVSFMO PERMIT NUMBERS. Must be valid and active permits.
- ➤ MAGAZINE PERMIT IF APPLICABLE for the purpose of this rule All display fireworks and pyrotechnic products **delivered prior to the day of display** shall be stored in an Outdoor Magazine: Type 1, 2, 4 or 5 only. If a magazine permit is needed, you must also obtain an explosive storage permit from the WVSFMO. This is a separate application and can be found at WV.firemarshal.gov.
- ➤ PYROTECHNICIANS AND PYROTECHNICIAN-IN-TRAINING LICENSES and any other required documentation requested on the application.
- > INVOICE AND PRODUCT RECAP from the fireworks supplier.
- ➤ APPROVAL AND SIGNATURE OF LOCAL FIRE CHIEF. (Found in section 8 of the application)
- ➤ DETAILED SATELLITE MAP to scale of the Display Site. Indicate the firing site, spectator area, nearest roadway, etc. and mark distances in feet. The Fire Chief or legal designee <u>MUST SIGN THE MAP!</u>
- ➤ CERTIFICATE OF INSURANCE Proof that the applicant maintains at all times, public liability and product liability insurance with minimum coverage limits of \$1,000,000.00 to cover losses, damages or injuries that might result from the public display of fireworks. (103CSR4 § 7.2.c)
- AUTHORIZATION LETTER FROM PROPERTY OWNER/LANDLORD of the display site. Even if the applicant is the property owner, a separate authorization letter must accompany the application.
- ➤ MARINE EVENT APPICATION (IF APPLICABLE) If the launch site is on or over the water, or will affect any body of water, copies of the completed "Application for Marine Event" and the "Fireworks Addendum to Application for Marine Event" must be included. Note: This application must be submitted to the U.S Coast Guard at least 135 days prior to the event.
