**Instructions and Information on obtaining a West Virginia Explosives Permit**

1. Please complete the application printed legibly in pen or using a computer.
2. Processing of your application will be delayed if this application is incomplete.
3. Submission of the application does not authorize the applicant to engage in the requested activity. You must obtain the actual permit before commencing operations. Please submit your application at least 30 days prior to your planned start of operations.
4. A separate application is required for each property on which explosives are stored.
5. All requirements of NFPA 495, Explosive Materials Code, must be complied with
6. If you obtain a manufacturing license, you **are not** required to obtain a separate dealer's license.
7. With this application you must submit a copy of your WV business license, current workers compensation insurance coverage, current general liability insurance coverage, a copy of your federal ATF permit, a site map clearly indicating the location of any and all magazines in reference to any landmarks or roadways, signed affidavit that all employees with access to explosives are proficiently trained and compliant with all federal and local licensing laws, a list of all individuals (including last 4 of soc.sec.#s) with access to explosives.
8. If your application is approved, you will receive an invoice via email. You will then submit the invoice with the appropriate fee and will receive your explosive permit via email. If the application is denied, we will advise in writing the reason(s) for denial.

9. Definitions:

**Manufacturing:** Engaging in business of manufacturing explosive materials for purpose of sale or distribution or for his / her own use.

**Dealer:** Engaging in business of distributing explosive materials at wholesale or retail

**Storage:** Any explosive material that will be stored overnight in West Virginia.  
Day-boxes, Wet-hole Trailers and other temporary storage magazines do not have to be registered with the State Fire Marshal
