## **COMMENTS**

Glenn Whittington, WV Firemen's Association. Stated he wanted to address the issue of emergency vehicle permits being suspended. He wanted to know if it was only new requests that were suspended and not the ones that have been issued in the past. Fire Marshal Lewis stated that was correct. Mr. Whittington stated he would like to know what the time frame was to start issuing them again. Fire Marshal Lewis stated there is no set date but he was hoping that by August, the new administrative policy would be ready and the new paperwork would be ready to go back to issuing the permits. Mr. Whittington wanted to know if there was any way some people with good driving records could get an emergency vehicle permit. Fire Marshal Lewis stated that insurance is going to go out of sight if there is not any risk management. Discussion followed.

David Plume, RESA 8 Training – Mr. Plume stated on behalf of RESA 8 and all the fire departments in the area, they wanted to thank the Fire Commission for holding a meeting in their area.

## **UNFINISHED BUSINESS**

Opinion from Counsel regarding Junior Firefighters – Fire Marshal Lewis stated that Assistant Attorney General Stacy DeLong gave a written report of a discussion they had regarding children under 18 years of age entering a burning building under certain conditions. She feels that it is a tremendous liability on the fire department that allows this and it would be a great liability on the instructors that allow it. She also understands that not allowing junior firefighters to enter into a burning building does hinder recruitment and retention because that is what junior firefighters want to do. They want to fight fire. She stated that parental permission means nothing and advises fire departments make sure they have insurance coverage and they would be covered in case of an incident. Ms. DeLong will meet with counsel for the Department of Education regarding this and will report back to the Fire Commission at a later date.

Fire Code Changes submitted by Charleston Fire Department – Commissioner Gunnoe stated he was advised that Fire Marshal Lewis will write a letter to the Charleston Fire Department regarding these changes can be made at the local level and would have to be done through city ordinance and city council.

Complaint regarding Ronceverte Fire Department – Counsel for Casey Morgan and Ronceverte Fire Department, Mr. Mark Moreland, was contacted by phone to participate in the discussion. A hearing date of April 25<sup>th</sup> at 9:30 AM was set.

Fire Marshal Lewis stated this hearing was scheduled because of a convicted felon on a fire department. The fire department has sent the same name three times to City Council for Fire Chief of the fire department. The name sent is a convicted felon.

On Monday, April 18<sup>th</sup>, a cease and desist order was given to the fire department from the Fire Marshal's Office. They are not running fire calls.

Fire Marshal Lewis stated that Deputy Fire Marshal Cook has removed by letter and/or phone calls approximately 27 convicted felons to date on fire departments.

Request from Joe Spray II, regarding inactive member being an officer in fire department – New information was received regarding an active or inactive firefighter and that Mr. Spray didn't meet the 25% of calls. The rule is vague and doesn't address this issue. The Fire Marshal's Office has spoken with Mr. Spray and he is okay with the explanation of the fire department bylaws.

Run area for Hookersville-Muddlety VFD – Fire Marshal Lewis stated the fire department would be ceasing to be a fire department due to lack of manpower. The 911 Center and County Commission have reverted back to the area that was covered prior to the establishment of the fire department. He stated it was staff's recommendation that the Fire Commission accept those boundary changes. Commissioner White made motion to accept staff's recommendation. Commissioner Goodwin seconded the motion. Roll call vote was called for. Commissioners voting for the motion were Commissioners Butcher, Clayton, Goodwin, Gunnoe, James, Miller, Mongold, Shriver, Sizemore, Sullivan and White. Commissioners absent were Mr. Keefer and Mr. Scott. Motion passed.

Fire Department Evaluations of Washington Lands VFD, McMechen VFD, Big Otter VFD, Baisden VFD, Matewan VFD, Wharncliffe VFD and Big Wheeling Creek VFD – Fire Marshal Lewis stated that Washington Lands VFD, McMechen VFD, Big Otter VFD and Baisden have obtained a level to be recertified. Commissioner Mongold made a motion to accept the evaluations of these fire departments for recertification. Commissioner Miller seconded the motion. Roll call vote was called for. Commissioners voting for the motion were Commissioners Butcher, Clayton, Goodwin, Gunnoe, James, Miller, Mongold, Shriver, Sizemore, Sullivan and White. Commissioners absent were Mr. Keefer and Mr. Scott. Motion passed.

Fire Marshal Lewis stated that Matewan VFD and Wharncliffe VFD have been evaluated and reevaluated and failed to come up to the level of approval needed for recertification. Staff is recommending a probation period of 60 days for equipment and 180 days for training. A hearing will need to be scheduled. Commissioner Butcher made motion to accept staff's recommendation. Commissioner Sizemore seconded the motion. Roll Call vote called for. Commissioners voting for the motion were Commissioners Butcher, Clayton, Goodwin, Gunnoe, James, Miller, Mongold, Shriver, Sizemore, Sullivan and White. Commissioners absent were Mr. Keefer and Mr. Scott. Motion passed. Fire Marshal Lewis stated it is staff's recommendation to have Matewan VFD at 11:00 AM on 4/25/2011 and Wharncliffe at 12:00 Noon on 4/25/2011.

Fire Marshal Lewis stated in reference to Big Wheeling Creek VFD, Marshall County, this is their second offense of noncompliance of any type of workers compensation or insurance for their members. After numerous attempts to contact any members of the fire department, counsel made a contact. They would not accept registered mail. They are not running any fire calls. He stated staff's recommendation would be a public hearing for withdrawing recognition. Commissioner Clayton made a motion to accept staff's recommendation. Commissioner Sizemore seconded the motion. Roll call vote was called for. Commissioners voting for the motion were Commissioners Butcher, Clayton, Goodwin, Gunnoe, James, Miller, Mongold, Shriver, Sizemore, Sullivan and White. Commissioners absent were Mr. Keefer and Mr. Scott. Motion passed. This hearing will be scheduled for 4/25/2011 at 2:00 PM. It will not be mandatory for them to appear.

Haz Mat Awareness Course meeting OSHA requirements – Commissioner James stated that it was a refresher course and the Training Committee did not think it was necessary to adopt because it is an OSHA requirement and the fire service uses mainly NFPA Standards. Commissioner James made a motion to not adopt the Haz Mat Awareness Course as submitted. Commissioner Miller seconded the motion. The ayes and nays having been taken on a voice vote, the motion passed.

Marcellus Shale Fires – A lengthy discussion was held in committee meetings. Fire Marshal Lewis stated that Tom Hart sent a letter of inquiry asking what training was available for first responders to respond to gas well fires, i.e. Marcellus Shale, etc. After researching this, it was found that only propane training was offered which is not completely different but there are different approaches. Commissioner James stated that Mark Doty of WVU and Mike Freeman, RESA 7, stated detailed future training may be developed for natural gas incidences. Discussion followed.

Applications for Fire Officer I and II – Commissioner Sizemore stated the committee met. The list of applicants for Fire Officer I and II is attached to these minutes. Commissioner Mongold made a motion to accept the committee's report for applications for Fire Officer I. Commissioner Miller seconded the motion. Commissioners voting for the motion were Commissioners Butcher, Clayton, Goodwin, Gunnoe, James, Miller, Mongold, Shriver, Sizemore, Sullivan and White. Commissioners absent were Mr. Keefer and Mr. Scott. Motion passed

Commissioner White made a motion to accept the committee's report for applications for Fire Officer II. Commissioner Butcher seconded the motion. Commissioners voting for the motion were Commissioners Butcher, Clayton, Goodwin, Gunnoe, James, Miller, Mongold, Shriver, Sizemore, Sullivan and White. Commissioners absent were Mr. Keefer and Mr. Scott. Motion passed.

Compliance with NFPA Standards concerning prerequisites for all Fire Officer courses, Firefighter 2 to be added – Commissioner James stated that due to an oversight to comply with standards that Firefighter II is a prerequisite for Fire Officer courses and to correct the NFPA Standards, this course must be added. Commissioner James made a motion to add the Firefighter II as a prerequisite to all Fire Officer courses. Commissioner Gunnoe seconded the motion. Roll call vote called for. Commissioners voting for the motion were Commissioners Butcher, Clayton, Goodwin, Gunnoe, James, Miller, Mongold, Shriver, Sizemore, Sullivan and White. Commissioners absent were Mr. Keefer and Mr. Scott. Motion passed.

Structural Collapse Training Class presented by RRT/State Fire Marshal – This course was requested to be proprietary. Commissioner James stated that WVU and the RRT Teams, and Task Force Urban Search and Rescue, are going to meet and discuss as to who can teach the course. Commissioner James made a motion that the Structural Collapse Class be proprietary to WV Task Force One RRT Urban Search and Rescue Program. Commissioner White seconded the motion. Commissioners voting for the motion were Commissioners Butcher, Clayton, Goodwin, Gunnoe, James, Miller, Mongold, Shriver, Sizemore, Sullivan and White. Commissioners absent were Mr. Keefer and Mr. Scott. Motion passed.

Approval of Additional Location for Parker Training Services for Home Inspectors

– Commissioner Shriver stated the committee discussed this subject and it was decided that approval is not required for an additional location.

Approval of request from Dominion Hope Gas to provide training

– Commissioner Shriver stated the committee had a presentation from Ben Williamson for Dominion Hope Gas. They are offering 3 courses for continuing education credits for the Building Code Officials as well as the inspectors. Commissioner Shriver made a motion to accept them as a course provider for providing the continuing education. Commissioner Butcher seconded the motion. Roll call vote was called for. Commissioners voting for the motion were Commissioners Butcher, Clayton, Goodwin, Gunnoe, James, Miller, Mongold, Shriver, Sizemore, Sullivan and White. Commissioners absent were Mr. Keefer and Mr. Scott. Motion passed.

Sprinkler requirements for nightclubs-time frame

– Fire Marshal Lewis stated that NFPA has a standard for sprinklers installed in nightclubs. It is staff's recommendation after reviewing the standard, to allow five (5) years from date of adoption before applying this code. Commissioner Shriver made the motion. Commissioner White seconded the motion. Roll call vote was called for. Commissioners voting for the motion were Commissioners Butcher, Clayton, Goodwin, Gunnoe, James, Miller, Mongold, Shriver, Sizemore, Sullivan and White. Commissioners absent were Mr. Keefer and Mr. Scott. Motion passed.

Support for the adoption of 2009 International Energy Conservation Code

– Commissioner Shriver stated this subject was brought before the Fire Commission at the last meeting and discussed in the committee meeting. Commissioner Shriver made a motion to request the Fire Commission to reaffirm their position that the 2009 International Energy Code be adopted. Commissioner Sizemore seconded the motion. Roll call vote was called for. Commissioners voting for the motion were Commissioners Butcher, Clayton, Goodwin, Gunnoe, James, Miller, Mongold, Shriver, Sizemore, Sullivan and White. Commissioners absent were Mr. Keefer and Mr. Scott. Motion passed

Approval of an online EMS Haz Mat Awareness course for use by firefighters

– Fire Marshal Lewis stated that some fire departments have requested to use an online program that has been approved by the State Office of Emergency Medical Services that they use as a refresher for their annual recertification. The question has been asked as to whether they may use this online refresher course as a Haz Mat Training for firefighters. Discussion followed. Fire Marshal Lewis stated it is staff's recommendation that the Fire Commission take no action. The program is available and fire departments can use it for an in-house refresher if they want but it is not required.

Approval of two forms submitted by RESA for use by firefighters requesting equivalency for courses completed in other jurisdictions

– Commissioner James stated the forms were submitted by RESA. The forms are to be used if a firefighter comes in from another state and needs to know how to apply in West Virginia for credit of courses taken elsewhere. There are two forms, one is called Firefighter Equivalency Application and the other is Verification of Firefighter Training. Commissioner James made a motion to accept these forms. Commissioner Goodwin seconded the motion. The ayes and nays having been taken on a voice vote, the motion passed.

## **NEW BUSINESS**

Review of NIOSH Report on Investigation of Death of Donnie Adkins – Chairman Sullivan stated this report was discussed during committee meetings. Fire Marshal Lewis stated there were two issues in the report that staff did not agree with. One issue was that NIOSH questioned the apparel the deceased was wearing. He felt he was in adequate swift water apparel. The other issue was a question by NIOSH of the boat commander's risk assessment. They had already made four rescues and brought 15 people out and they were making their last trip in and something hit the motor which threw the boat out of control.

Reallocation of Bridgeport Volunteer Fire Department's first due area – Ron Watson, Harrison County Commission, requested to withdraw from New Business for any action to reallocation or divide up the first due area for the fire department. He stated there is a lot of questions regarding the home rule and whether the fire fee is legal. Discussion followed. Chairman Sullivan stated there is no issue at this time.

Boundary Dispute between Maysville VFD and Petersburg VFD, Grant County – Deputy Tony Carrico stated he and Fire Marshal Lewis traveled to Grant County to resolve the issue between two fire departments there. When they left, they thought the issue was resolved. Now, the County Commission have officially requested that the areas be reevaluated. A map was received from the county, however, there was no scale. Therefore, they could not evaluate areas without a scale and they have requested new maps with scale to be sent to the Fire Marshal's Office.

Approval of continuing education course by ProStar Academy/Inspection Technology Institute – Commissioner Shriver stated he would like to make a motion for approval of the ProStar Academy as a course provider for the home inspectors. Commissioner Miller seconded the motion. Roll Call vote was called for. Commissioners voting for the motion were Commissioners Butcher, Clayton, Goodwin, Gunnoe, James, Miller, Mongold, Shriver, Sizemore, Sullivan and White. Commissioners absent were Mr. Keefer and Mr. Scott. Motion passed.

Chairman Sullivan appointed a new Committee called Fire Department Services to coordinate the efforts of staff's development of a new division. He appointed Commissioner Butcher as Chairman of the committee along with Commissioner Mongold and Commissioner Gunnoe. They will be addressing issues such as health & safety, risk management for fire departments, evaluating current professional standards and suggestions for workers compensation.

Commissioner Gunnoe stated he and Commissioner Sizemore met with a local individual who wanted to be here today but due to a serious illness in the family, he wasn't able to. He works with local county government now as an emergency services fire coordinator and he is involved in that field. He is looking for some assistance from the Fire Commission. He was with a local municipality as a fire marshal for 20 years or so and now he is working with county government and they are paying him and they have adopted the State Fire Code but they are wanting him to be able to go out and do some code enforcement with all the new growth that is going on in the area. He can't find any way that he can actually do that since he's not with a volunteer fire department. He doesn't know how to get the authority to do code enforcement. He would like to see

if the Fire Commission or Fire Marshal can help him. Commissioner Gunnoe requested staff to look into this situation.

Fire Marshal Lewis stated the office has worked with him, researched the code and there is nothing in the code that allows the Fire Marshal's Office to grant his request. He stated they will continue to work on this situation.

Commissioner Shriver stated at the last meeting, they were presented with a proclamation from the International Code Council Foundation requesting the Fire Commission proclaim the month of May be National Safety Month. Commissioner Shriver made a motion that the Fire Commission accept the proclamation. Commissioner Mongold seconded the motion. The ayes and nays having been taken on a voice vote, the motion passed.

### **CORRESPONDENCE**

All correspondence was in reference to Harrison County and Bridgeport VFD.

### **STAFF REPORTS**

Fire Marshal Lewis stated his report has been completed through Old and New Business.

### **AGENCY REPORTS**

**Technical and Adult Training, Vo-Tech,** David Plume, RESA 8, Public Service Training. He stated that Mr. Hicks stated they had met with their attorney regarding live burns with junior firefighters. Mr. Hicks wanted to state the Department of Education's point of view is that the issue is not entering a burning building in response to an emergency call. The issue is being able to view live burn training to get certification as Firefighter 1. Mike Freeman has done some research on some of the issues with gas wells and also on fire investigation curriculum. They are very busy with training.

**Training, WVU-FSE,** Mr. Mark Doty stated they had a seminar with 94 participants. The National Fire Academy Weekend is scheduled for October 8 & 9. This is open to any firefighter. This is on their website. The Junior Firefighter Camp is scheduled for June 25-30. They have had more pre-registration than ever before. They hope to unveil some new props and mobile compliance base equipment at the Junior Firefighter Camp.

**Insurance Services Office (ISO),** Mr. Ron Bateman introduced Mr. Phil Leitma, senior field rep who works the Eastern Panhandle area and Bob Glunt, senior field rep for Pennsylvania. Commissioner James asked about the new Field Survey and if it was released yet. Mr. Bateman stated, "no, it has not". It probably won't be out until the end of the year. Commissioner James asked about the required manpower on first due out increasing? It is still in draft form but they think it will stay at 4.

Fire Marshal Lewis stated he had heard two concerns: (1) ISO has already submitted new ratings. They stated it was not true. (2) That the radius might change to 6 instead of 5. Mr. Bateman stated as far as he knows it went to 6 just for West Virginia. They stated after the final draft is released, they will be putting on seminars.

## **COMMITTEE REPORTS**

**Training Committee.** Commissioner James stated the committee met on April 14, 2011. A copy of the minutes of the committee meeting is attached to these minutes.

**FD Standards Evaluation.** Commissioner Sizemore stated he had received quite a few applications for Fire Officer I. A list is attached to these minutes. Commissioner Sizemore made a motion to approve this list. Commissioner White seconded the motion. Roll call vote called for. Commissioners voting for the motion were Commissioners Butcher, Clayton, Goodwin, Gunnoe, James, Miller, Mongold, Shriver, Sizemore, Sullivan and White. Commissioners absent were Mr. Keefer and Mr. Scott. Motion passed.

Commissioner Mongold made a motion to approve the list of applications for Fire Officer II. Commissioner Miller seconded the motion. Roll call vote called for. Commissioners voting for the motion were Commissioners Butcher, Clayton, Goodwin, Gunnoe, James, Miller, Mongold, Shriver, Sizemore, Sullivan and White. Commissioners absent were Mr. Keefer and Mr. Scott. Motion passed.

**Recruitment and Retention Committee.** Commissioner Mongold stated he received a phone call from Bradley Prosperity VFD regarding 1-800-FIRELINE. They will meet and it is a phone system that will give contact information regarding the fire departments in the caller's area. Fire Marshal Lewis stated an Assistant Fire Marshal would like to participate with this program and he will get the information to Commissioner Mongold.

**Special Issues Committee.** Commissioner Goodwin stated the committee met. There is nothing to report.

**Procedures and Development Committee.** Commissioner Clayton. No report.

**Public Education Committee.** Commissioner Clayton stated he had no report, however, Deputy Fire Marshal Carrico stated there is a new way to search for information on the website. There is a searchable database that can be searched by various fields for fire departments and also for electrician licensee search.

**Legislative Committee.** Commissioner Gunnoe stated they met on April 14<sup>th</sup>. There was general discussion about legislation that was passed in the recent session. He reported on legislation passed that affects career fire departments.

Fire Marshal Lewis reported on the workers comp issues that were passed during the Legislative session in regards to funding of approximately \$5 million dollars to help out the workers comp situation.

**Home Inspectors, Building Code Officials, Building and Fire Code Committees.** Commissioner Shriver stated the committee met on April 14<sup>th</sup> and discussed the request from the City of Charleston and the support of the 2009 International Energy Code. They also discussed the proclamation from the International Code Council in regards to Building Safety Month for May. They also discussed the ProStar Academy for their class for home inspectors as well as the Dominion Hope Class for continuing education to the building code officials and home inspectors.

The committee discussed the 2012 codes and when they would be published and when the Fire Commission could begin adoption of these codes.

He also stated there would be a side by side live burn at the Public Safety Expo in Charleston on May 18-20.

**TIME AND PLACE OF NEXT MEETING**

The next Fire Commission Meeting is scheduled for June 10, 2011, at the Comfort Inn, Summersville, WV. The meeting will commence at 9:00 AM.

Committee meetings will start at 10:00 AM on June 9, 2011.

**GOOD OF THE ORDER**

Fire Marshal Lewis requested prayers for the wife of an employee of the Fire Marshal's Office, Kathy Oliver, wife of John Oliver, Assistant Fire Marshal, Inspection Division, Wheeling, WV, is extremely ill.

Deputy Fire Marshal Carrico introduced a new employee in his division, Assistant Fire Marshal George Harms, came on board March 1<sup>st</sup>.

Effective May 1<sup>st</sup>, Tony Carrico will become Chief Deputy Fire Marshal.

**Minutes**  
**WV Fire Commission**  
**Training Committee Meeting**  
**April 14, 2011, Charles Town**

Meeting was called to order at 1340 hours at *The Inn at Charles Town*. There were six Commissioners and sixteen participants. Chairman James distributed the agenda with attachments.

The forms, "Firefighter Equivalency" and "Verification of Firefighter Training" were discussed. When in operation, the newly formed Fire Department Division of the State Fire Marshal's Office will receive the completed forms and verify their authenticity. These forms will be made available online. After approval, the Fire Marshal will contact the appropriate RESA for issuance of certificates.

Discussion on the "HazMat Awareness Refresher" course resulted in a "do not adopt" vote by the members of the Training Committee.

Mark Doty of West Virginia Fire Service Extension and Mike Freeman of RESA 7 detailed future training that may be developed for natural gas incidents.

New curriculum, "Ethanol, Response Consideration" was discussed. The Committee determined that this course did not fall under the core curriculum criteria. And, while an important course, the Fire Commission approval is not required.

RESA submitted new curriculum. While NFPA 1670 rescue courses are for the department size training, these new courses are geared to NFPA 1006 for the individual. This latest set of courses takes awareness, operations, and technical levels and combines them into two levels. Level 1 is not tested, but Level 2 is tested. The first course "Rescue Core Prerequisites" is a forty (40) hour course and is prerequisite to all the following:

Trench Collapse	Level 1	20 hours
Trench Collapse	Level 2	32 hours
Rope Rescue	Level 1	20 hours
Rope Rescue	Level 2	20 hours
Confined Space	Level 1	20 hours
Confined Space	Level 2	20 hours
Swift Water	Level 1	24 hours
Swift Water	Level 2	18 hours

West Virginia Fire Service Extension will review the newly submitted curriculum and report to the Training Committee. The curriculum will be placed on the next Training Committee agenda for June 9 and full Commission Meeting on June 10.

The Fire Marshals' Office requested to be removed as proprietary sponsor of Fire Investigation, Levels 1, 2, and 3. The Marshals' Office will compile a list of instructors they feel qualified and make the list available to the education partners.

Lanny Adkins and Mark Doty of West Virginia Fire Service Extension presented reports. They will elaborate when they give their reports to the full Commission on Friday.
