One item of note was the emergency rule ran for §87-1. The circumstances constituting the necessity for the emergency rule are:

An emergency exists requiring that this emergency rule be promulgated to address the time-sensitive nature of the upcoming fair and festival seasons in the Spring and Summer seasons of 2025 with relation to limited use food preparation facilities. This rule could not be amended through the legislative process until 2026 and there is an emergent need for the exception included in this emergency rule this summer. This emergency exists for the immediate preservation of the public peace, health, safety and welfare of those attending fairs this summer as the Fire Code establishes the safeguarding of life and property from the hazards of fire and explosion. Also, the emergency exists to comply with the time limitation to have this emergency rule in place this summer, as there were situations last summer that necessitated a change in the rule.

Marshal Tyree explained that in addition a public hearing will be required on §87-1 to amend the existing rule and will be scheduled as soon as possible.

The basis of the complaint was the lack of preparedness as a Fire Department Engine on a fire scene had no water and at the same scene there were children in another In-Service Department Vehicle.

In a written response to the letter notifying the department of the complaint, Chief Morrison stated that he had already addressed the truck not being properly prepared with the Firefighters responsible in doing so. As for the children, he responded to the scene without the use of red lights or siren and parked at a residence away from the scene and at no time did the children exit the vehicle. He was not aware that having children in the vehicle was not allowed.

Commissioner Mongold asked Chief Morrison to step up to the podium and Chairman Gunnoe inquired if there was anything else he wished to add. Chief Morrison explained it was an oversight regarding the truck not having

water and it had been addressed with those involved. As for the children, it was a mistake on his part for not being aware that they could not be in the vehicle.

Chief Morrison was asked if the department had a written policy about children in department vehicles to which he replied he would have to look at the policy and by laws, but he plans on implementing said policy if it doesn't exist.

Commissioner Gunnoe made a motion to recommend to the Full Fire Commission that the Fire Marshal's office work with Chief Morrison to ensure that the appropriate policy with the necessary language to be in compliance with State code, be put in place by the department and provided to the Commission for the June meeting, seconded by Commissioner George. With the ayes and nays having been taken on a voice vote, the motion passed.

### **2. WVU-FSE Report**

Mark Lambert of WVU-FSE reported - The 2024 pass fail rates; He made the Committee aware that their Junior Camp was named the National Junior Camp of the Year by the National Volunteer Firefighters Council and the award will be presented on the last day of Camp on June 19<sup>th</sup>, 2025. To that camp they are adding some nutrition classes and for the 16-17 age attendees they will address PTSD and suicide prevention; WVU-FSE is working with the Propane Gas association to do 3 training classes to include both classroom and field training. The association is very concerned about firefighters getting the appropriate training and they have allocated monies for the training; The Tri-State Fire Chief school was held in Cabell county and was well attended; FF1 as a college level class is going to be offered over 2 semesters and if you pass the class, skills and test you will be Pro-board certified; He noted for informational purposes that the National Fire Academy is not offering any classes right now; Lastly he and another professor are about to publish a paper on Fire Fatalities in WV in order to build a foundation on why there are so many fatalities.

Marshal Tyree asked if the National Fire Academy had the ability to contract off campus classes and Mr. Lambert replied that it was not available at this time. Marshal Tyree inquired of Mr. Lambert what the cost to replicate what they do at the NFA burn cells they build. Mr. Lambert thought it would be anywhere from \$250,000 to \$500,000.
