Commissioner Eastham made a motion that based upon the investigation it was found that a threat was made, and that action is necessary on FDC 2024-027 and 028, seconded by Commission Shriver. With the ayes and nays having been taken on a voice vote the motion passed.

Chairman Gunnoe noted that based on all the information from all parties involved and the subsequent investigation it was determined that the Commission needed to act.

Commissioner Eastham made a motion to send a letter to the governing board of Lenore VFD containing the following wording with edits as grammatically necessary:

Based on the investigation conducted by the State Fire Marshal's Office and the testimony taken by the West Virginia Fire Commission on December 5, 2024, at our meeting held in Parkersburg, West Virginia, the Fire Commission determined that a threat of bodily harm was made by Chief Farris toward Firefighter Marcum on a fire scene.

Therefore, we are requesting the governing board of the Lenore Volunteer Fire Department make a recommendation to the Fire Commission as to any action they feel is appropriate to take toward the Fire Chief.

The Fire Chief shall remain on temporary suspension until the Fire Commission receives the requested information from the governing board. This Commission is requesting that the board's recommendation be made by the board and submitted to the Fire Commission in writing.

In the written recommendation, any information as to who is on the board making the recommendation along with a copy of any minutes of the board meeting with a copy of the board's bylaws should also be provided to the Fire Commission.

seconded by Commissioner Mongold. With the ayes and nays having been taken on a voice vote, the motion passed.

Christopher Haynes of the Lenore VFD inquired about how the process will proceed.

Chairman Gunnoe noted that once that recommendation is received there will be a special meeting if necessary and all parties will be notified appropriately.
