5. Discussion on 87CSR6

Marshal Tyree discussed a meeting that was held at the request of Senator Jeffries, and Senator Woodrum over the authority of the Fire Commission/Fire Marshal's office to intervene, as necessary in the operations of a VFD when it comes to public safety. Concerns had been raised due to a recent issue where multiple members of a VFD left in one evening, resulting in low staffing levels, lack of mutual aid support and the public feeling that their needs were not being met. At the time, the agency did not believe they had the authority to act but Counsel has advised that §87-6-5.1.10 does give the authority to intervene if a complaint has been registered that concludes public safety is at risk.

A discussion on the matter and the complaint process ensued and Marshal Tyree entertained questions from the Committee, members of the Commission and the public.

No Action Taken.

6. Consideration of Ruling on Applicability of W.VA Code §8-15-1

Marshal Tyree addressed the Committee on a letter from the Putnam County Commission requesting a determination of whether W.Va Code §8-15-1 or Fire Commission Rule 87CSR6 would take precedence regarding a change to the county fire protection boundaries.

Per Counsel, Code/Statute trumps Rules, therefore §8-15-1 would apply.

Commissioner Gunnoe made a motion to recommend to the Full Fire Commission that counsel draft a letter of response to the Putnam County Commission, explaining that §8-15-1 is applicable, and that the Commission will approved the new boundary in a separate business, seconded by Commissioner Mongold. With the ayes and nays having been takin on a voice vote, the motion passed.

After some discussion with the Committee and the knowledge that the Commission can only issue FDID numbers to certified Fire Departments and what is required to be certified, Mr. McGinness requested the Committee table the matter until the December meeting.

1. Public Service Training Report

Mr. Mike Freeman of Public Service Training spoke of the upcoming Escape Conference on February 26th through March 2nd of 2025 and that the Asset Conference will be December 5th-7th of 2025. He noted frequent requests to expand IFSAC certification courses and that the processes have begun to do so. He also discussed the addition of QR verification codes on their certificates. He provided a sample certificate to the Committee members, so they could see how the QR codes work.

2. WVU-FSE Report

Mr. Mark Lambert of WVU FSE addressed the Committee with following updates: The next Junior Camp will be held on June 14th-19th of 2025, and that October addition of Fire House magazine will have a story on the camp; The reception of a \$500,000 AFG grant; While in Illinois he attended a roundtable discussion about recruitment and retention that had 35 States represented. One of the biggest concerns they saw was Fire Station Culture and the problem with groups and clicks; The Alternative Fuels Vehicle Training program is going well; and WVU FSE will be going to digital credentialing for verification.

4. OSHA Statement Re: Emergency Response Rulemaking and Volunteer Emergency Responders.

Mr. Anthony Milam the OSHA Compliance Assistance Specialist in the Charleston WV office addressed the Committee regarding the September 17th, 2024, statement issued by OSHA regarding the proposed Emergency Response Standard. A large volume of public comments has been received over the concerns of the financial feasibility of volunteer organizations to meet these proposed standards. While the public comment period closed, OSHA asks that groups affected continue to make comments, up until the November 12th, 2024 rulemaking hearing, so they can understand, how this may affect volunteer groups.

A lengthy discussion on the potential affect to over 400 VFD's that operate independently of a City, County, or State was embarked upon. Committee, Commission, Staff and the public in attendance all voiced their concerns over the potential financial and legal problems the proposal could result in, and the possible end to many VFDs.

Commissioner Mongold made a motion to recommend to the full Commission that letters be sent to our US Congressional and US Senate members in opposition to the Emergency Response Standard, seconded by Commissioner Estep. With the ayes and nays having been taken on a voice vote, the motion passed.
